

PERRY COUNTY BOARD OF COMMISSIONERS
MINUTES – July 3, 2023

The Perry County Board of Commissioners met at 9:00 a.m., as was duly advertised. Commissioners: President Randy Cole (RC), Rebecca Thorn (RT), and Randy Kleaving (RK) were in attendance. Auditor Chief Deputy Kelli Wilgus and Attorney Andrew Foster were also present. There was no *Sheriff Representative or News Representative* in attendance.

The meeting opened with all present reciting the Pledge of Allegiance.

AGENDA

RT made a motion to approve the agenda as modified, seconded by RK. Motion carried 3-0.

PUBLIC COMMENTS

- a) Commissioner Randy Cole began with a statement that this morning our community experienced something none of us expect to happen in a small community. A Tell City Police Officer lost their life and the individual involved in the incident also lost their life. The families are a part of our community and have been for years. With respect to the family, we will be closing the county offices as of 12:00 p.m. today due to statutory requirements associated with the election and the requirement to keep the Clerk’s Office open. At 12:00 p.m. we will cease operations and open back up July 5, 2023. This decision was unanimous by the commissioners to approve this. This will be an abbreviated meeting to only pay payroll, vendors, and one other issue dealing with the Tax Sale coming up. The remainder of the items will be on the next meeting agenda.
RT mentioned prayers and thoughts are with all involved. RK recommended lowering flags in the community until after the funeral.
