ORDINANCE <u>0-C-22-5</u>

## AN ORDINANCE AMENDING THE PLAN ESTABLISHED PURSUANT TO ORDINANCE 2021 CO-Q-C-2!-3

WHEREAS, the County adopted Ordinance 2021 CO-0-0 establishing "The ARP Coronavirus Local Fiscal Recovery Fund" so the County could receive American Rescue Plan funds; and,

WHEREAS, said ordinance required The Perry County Board of Commissioners to develop a plan that will detail the specific uses of the funds as required by the ARP and also provided that any specific appropriations approved by the County Council of Perry County shall be deemed a part of the Plan, or an amendment to that Plan, as appropriate, when such appropriations are made; and,

WHEREAS, the Perry County Commissioners have adopted a plan as amended from time to time for the use of the ARP funds; and

WHEREAS, the Perry County Commissioners and the Perry County Council have appointed an ARP Advisory Committee to assist in developing a plan and awarding funds pursuant to that plan to be recommended to the Perry County Council as the fiscal body; and

WHEREAS, the US Treasury has adopted final rules which allow up to \$10,000,000 of the ARP funds awarded to be designated as a Standard Allowance of Revenue Loss without proof of actual revenue loss due to the pandemic; and,

WHEREAS, the Perry County Council passed a resolution that, if the Perry County
Commissioners changed the plan for use of the ARP funds to designate 100% of the \$\frac{3.72}{2.72}\$ which awarded to Perry County as the Standard Allowance of Revenue Loss and provided that said money may be used for general government services subject to the restrictions of the final rule, the Perry County Council would consider the recommendations of the ARP Committee in appropriating payments from that fund.

NOW THEREFORE BE IT ORDAINED by the County Commissioners of Perry County, Indiana as follows:

1. The plan approved by the Perry County Commissioners for the use of funds received by Perry County from the American Rescue Plan and placed in "The ARP Coronavirus Local Fiscal Recovery Grant Fund Number 950" established pursuant to Ordinance Number 2021 CO-0-2-3 is hereby amended to provide 100% of the \$3.72 awarded to Perry County shall be designated

as the Standard Allowance of Revenue Loss and that said money may be used for general government services subject to the restrictions of the final rule, as agreed to by the Perry County Council.
