

COUNTY COMMISSIONERS' ORDINANCE NO. 0-C-21-4

WHEREAS, by Ordinance No. 0-C-21-1, the County Commissioners have adopted a Capital Improvement Plan for Perry County to specify uses of revenue to be received by Perry County for the three (3) year period beginning January 1, 2021; and

WHEREAS, it is necessary to amend the Capital Improvement Plan to utilize a part of the revenue to perform certain work at the Industrial Park South entrance road.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Perry, Indiana that the Capital Improvement Plan dated as of January 1, 2021 is hereby amended as follows:

1. An amount up to Eighty Thousand Dollars (\$80,000.00) may be paid from CEDIT Distribution Fund No. 7312 to perform work on the Industrial Park South entrance road.
2. The remaining portions of the Capital Improvement Plan shall remain in full force and effect as is fully set forth herein.

Re: Resurfacing of Perry County Industrial Park South entrance road

Location: Perry County Industrial Park South entrance road (ATTC Way) located west of SR 37 north of Tell City just south of the 4 mile marker.

Request for Quotation per the following described work:

The price shall include the work to accomplish the resurfacing of the entire paved entrance road from the west end to the SR 37 turn lane. The width shall be from edge to edge and curb gutter pan to curb gutter pan. Work to be accomplished:

- Furnish and provide traffic control appropriate for the safety and protection of workers and traveling public for the site.
- Patch the 2 existing deteriorated areas which include a pot-hole and an edge deterioration area. Excavate 4" below milled depth and fill with HMA 25mm mix. Edge patch should stabilize subgrade and shoulder as necessary with #53 aggregate. Excavated material may be dumped in area near watertower.
- Mill 1" of existing surface width as previously described. Milled material shall be tailgated on road to watertower, smoothed and compacted.
- Place tack coat on edges and milled surface.
- Place 1.5" of HMA 9.5 mm mix over milled pavement.
- Stripe new surface as currently striped.
- Work shall include the milling and paving full width of the SR 37 approach to the turnlane.

Timeline – This work can be accomplished as early as you desire, but must be completed by Labor Day, 2021.

**Provide appropriate supervision and traffic control for the project.**

This request for quotation is being offered by the Perry County Development Corporation acting as Project Manager for the Perry County Commissioners on this EDIT funded project of Perry County Redevelopment Commission owned property. Indiana Statute purchasing procedures apply to this purchase.

Quotations are due no later than 4 PM May 17 and will be presented to the Perry County Commission at their 8 AM meeting on May 18.
